Engineering Assessment Includes Safety

The **Canadian Engineering Accreditation Board** (CEAB) now has a checklist on Occupational Health and Safety as part of its assessment of engineering programs at universities. "This is a major innovation," says Minerva Board member Vic Pakalnis, who was part of CEAB's visit to the University of Toronto Engineering Program last fall. Vic and fellow Committee member Renzo Dalla Via addressed CEAB at its annual conference in Charlottetown, PEI, two years ago, recommending that health and safety be integrated into the assessment and providing them with a suggested approach.

The new guidelines now have explicit questions to ask concerning occupational health and safety issues, including faculty and student appreciation of OH&S knowledge and a formal accounting of courses and textbooks used for OH&S instruction. ACADEMIC CORNER

One of the Minerva case studies — **Hydroelectric Generating Station Cover-Shield Failure** — will appear in a new business textbook used at the University of Saskatchewan, Ryerson University and other schools. An abridged version of Marc Rosen's case study is published in *Operations Management*, 2nd Canadian Edition, by Stevenson and Hojati (McGraw Hill, 2003). The case study details a "seemingly trivial" engineering failure that could have resulted in potentially serious consequences. The failure arose due to an oversight in a rational risk-based maintenance approach to an aging facility. The case highlights day-to-day safety issues common to many industries. "This gives us a foot in the door of management textbooks, which will help to 'institutionalize' our message," says Minerva Committee member David Meston, who coordinated the submission with the publishers.
